## The Show Never Ends

The Holidays came like an arctic express and left a lot of cold behind, but that hardly slowed things down for WAR. A short list of things behind us and things on the horizon:

## Past & Prologue

CA has approved Citrus County's comprehensive plan amendment which will allow for multi use development on the Citrus Mining and Timber property and River Lodge LLC expansion. The proposal will allow for over 1,000 RV slips and/or workforce housing units which are planned to accommodate the Progress Energy plant contractor workforce. If this project meets its objectives expect a doubling of the population in our community. The amendment will also allow for virtually all other forms of development, ranging from hotels, bars, heavy industrial and continued mining.

B 360 which was signed into law by Gov. Crist has a provision which extends the life of existing Environmental Resource Permits by 2 years upon request by the permittee. This includes the Barge Slip ERP located on the Citrus Mining and Timber property.

he Senate Select Committee on Florida Inland Waters held a public forum in Ocala on 16 Dec. 2009 and I addressed the Committee on issues of statutory conflict and inconsistencies. Chairman Constantine requested I contact his staff for further discussion on this issue during the presentation and we have entered into this discussion. More information as this evolves.

Gerry Mulligan, Managing Editor of the Citrus Chronicle, gave Citrus County a grade of D for water resource protection and C- for economic development in his year end review of county government. I gave Gerry an A+ for that.

## **Task Force**

ost of you already know that due to a technical issue I am no longer a director of W.A.R. Inc. However, I have been enlisted by our executive director (Dan Hilliard) and the new Tarmac Task Force Director (Jack Schofield) to carry-on with my previous efforts of mobilizing the Troops, assembling and disseminating data, acting as liaison to the DEP and Army Corps of Engineers, and publicizing our side of the story. Perhaps the board, with your support, will consider a new post for me, Director Emeritus. This would provide me with unfettered access to governmental agencies and I would still be shielded by the organization's corporate umbrella.

Tarmac has experienced a slowdown in their permitting process. Several circumstances have combined to effectuate this deceleration. We of course erected huge hurdles that were totally unanticipated by them. Their own hubris in ignoring the Request for Additional Information (RAI) from the DEP, for several months, caused a further setback in their scheduling. It is now reasonable to assume that the economic climate for development in Florida today has all but eliminated any urgency that they were expressing when this process began, and thus they are in no hurry to obtain all their necessary permits, as they would have no customers for their rock.

Please don't be lulled into assuming that they are going away though. Battles remain in clear view and many more on the horizon. Examples of their intentions include, but are not limited to: recently reengaging in a disinformation campaign via press releases; making judicious donations to local groups to win favor; and continuing to lobby governmental groups and individuals for favorable considerations and determinations.

Our efforts to counter their hugely bankrolled endeavor rely on facts and the efforts by our supporters. Facts stand for themselves, but if not defended, can be distorted. If a lie is told enough times, and not exposed, it in fact, becomes reality to all who hear it often enough. We all see this during well-financed political campaigns. An issue before the Levy County Commission has thrown a bit of sand in the ointment for Tarmac LLC. It seems there were inconsistencies between what the Board voted for in approving the mine test pit Special Exception and what was inserted after the fact in the form of language that was not approved. The ERP extension approved by SWFWMD expired on 31 Dec 2009 and it would appear they will be required to either seek permit modification, revision to their special exception or fill in the test pit. I have been informed Tarmac applied for ERP extension to the SWFWMD on 28 Dec. 2009. Stay tuned.

Al Grubman, president of Too Far, Inc., is seeking appointment to the Governing Board of SWFWMD. Al's dedication to water resources is second to none in my opinion and he's the only person I know crazy enough to seek such a position for the pay that comes with the job. # Killing of the Lower Withlacoochee

Throughout Florida the Invasive Plant Bureau of the Florida Fish and Wildlife Conservation Commission conducts programs to eliminate "invasive plant species", from Florida waterways and lakes. This is done with a variety of herbicides also classified as pesticides in some literature. These chemicals are approved by the Federal Environmental Protection Agency and awarded licenses and labels restricting their application. What could possibly be wrong with using these products?

These are after all toxic chemicals designed to kill specific aquatic vegetation. Evaluation and experimentation is almost always carried out in bodies of fresh water with little or no flow, like farm ponds. Application levels are determined through these tests. Consider what happens when these herbicides are applied in rivers or streams. In order to maintain a level of chemical concentration high enough to kill the target plants the total amount of herbicide chemical added must be drastically increased.

Let's do an imaginary experiment where ping pong balls will be the herbicide. The plants in an area ten feet by ten feet in front of your dock can be killed by exposing them to two ping pong balls for a 24 hour period. If your dock is in a pond 10 feet deep with almost no flow we simply drop two ping pong balls off the end of the dock and in 24 hours the job is done. But what if your dock is on a river where the water is flowing by the dock at a rate of 2 feet per second, (just under 11/2 mph)? We will need to add 2 ping pong balls to the river every 5 seconds to get the same contact time, (exposure), with the plants. Can you believe 34,560 ping pong balls will be needed? Unfortunately, instead of ping pong balls we are dealing with one or more toxic chemicals.

**Y** / here do these chemicals go? Obviously only a small portion will be reacted with the plants in the 10 foot square area in front of the dock. The rest will go down stream until it contacts and reacts with vegetation in the river or is adsorbed on to inert materials and settles to the bottom of the river. In the case of the Lower Withlacoochee River, we observed the feed of the herbicide Sonar in Lake Rousseau survived the trip all way down the River at full concentration. For years the Bureau of Invasive Plant Management had maintained that these chemicals would break down and never reach the river, but no monitoring was done. Now we know the truth. It is our position that campaign after campaign of herbicide application in Lake Rousseau has resulted in the complete lack of aquatic vegetation on the bottom and wetted banks of The Lower Withlacoochee River. This is what
